Response Planning Team Update - March 27, 2020

Corporate Service Team (CST) Update

Questions have been asked about school playgrounds. There have been no provincial orders to close playgrounds. The only provincial direction regarding playgrounds is they are to be avoided by anyone who is in 14-day self-isolation. It is important that all public orders be followed including following proper social distancing protocols and ensuring high touch areas are sanitized. We recognize that consistency between municipalities and school divisions would be valued. We understand some municipalities have taken the pro-active measure to close city-owned parks. Some school divisions have also pro-actively communicated to inform families and the local community that surfaces at playgrounds are not cleaned or sanitized.

The CST members are working on many different issues and has prioritized:

- Plans for staff to return to work starting March 30 with options including working from home, staggered physical presence in school buildings, etc. that meets the Chief Medical Health Officer's provincial guidelines, including:
 - Limiting the size of public and private gatherings to a maximum of 10 people in one room, effective March 26, 2020. Exceptions are provided where two-metre distancing between people can be maintained, such as; workplaces and meeting settings where people are distributed into multiple rooms or buildings, and retail locations deemed essential.
 - Access to tools and other resources for staff.

An email address (covid19questions@saskschoolboards.ca) and page on the SSBA website has been developed specifically for division senior staff and administration to submit and access Q and A's. Information specific to individual school divisions will be distributed in a different manner, e.g. direct email, Data Warehouse, etc.

Instructional Services Team Update

The Instructional Services Team (IST) met on March 26, 2020 to complete the supplementary instructional framework. The framework in its entirety is being compiled into a single document and will be sent to school divisions.

The IST is working on creating Q and A's regarding the instructional aspect of the framework. School divisions are asked to use the email address covid19questions@saskschoolboards.ca to ask their questions.
